- **6. Manual** You can click on Bid Manually
- In the Manual Bid option, you can put your bid in the text box available for each ITEM and submit it every time. A bid confirmation pop up box will appear to confirming whether you want to go ahead with the bid posted or not. **If you confirm the bid, your bid will be posted.** If your bid is accepted, that will be displayed in “Your bid” column on your right side screen. Also the Lowest bid amount will be displayed in “Lowest bid” column. If you are the Lowest bidder at the time, **“Your Bid” column will be highlighted with “green” background.**

- During the auction, the current Lowest bid of the bidder, the bid status and the bid history can be viewed on the screen all the times. Bids can be placed at the specified time mentioned during the auction day.
