## **TERMS OF E-AUCTION / E-TENDER IN BRIEF**

1. For **e-tender**, bidders are to deposit caution money deposit of Rs.6,00,000/- for bidding of all lots in SECTION I, Rs 5,000/- for all lots in SECTION II and Rs 10,000/- for all lots in SECTION III Similarly for **e auction**, bidders are to deposit caution money deposit of Rs.6,00,000/- for bidding of all lots in SECTION I, Rs 5,000/- for all lots in SECTION II and Rs 10,000/- for all lots in SECTION III for all lots of SECTION II by Demand Draft A/c. "**CENTRAL WAREHOUSING CORPORATION**" payable at **Mumbai**, shall have to be submitted on 27-05-2017 before 2.00PM (for e-Tender) and 29-05-2017 before 5.30PM (for e-Auction) in the auctioneer office, without which no one can enter the auction room.

e-Tenders will be opened after auction closes on 30-05-2017 in the office of Regional Manager, CWC, RO, Navi Mumbai. (after completion of e-auction)
3. The bid/offers accepted on STC will be forwarded to Customs Department for Clearance so as to file Bill of Entry in the name of successful bidder/purchaser for approval/assessment of Customs Duty.
4. The confirmation of bid of cargo shall be intimated to successful bidders after Bill of Entry is approved by Customs Department. The bidders shall deposit the balance amount along with VAT within five (5) working days from the following date of issue of confirmation by CWC. However, delivery of auction goods shall be made after getting out of charge from Customs. If the bidder fails to deposit the balance amount and VAT within stipulated period of five (5) working days from the following date of confirmation, their EMD/CMD shall be forfeited. Bidders will be allowed to take delivery of the goods within five (5) working days from the date of out of charge. Bidders should be in touch with CWC to know the information about out of charge, any excuse of non receiving information will not be entertained by this office.
5. If the bidders fail to take delivery of the cargo within the stipulated time, as stated above, the Corporation, i.e., CWC may at its discretion extend the delivery period on request of the successful bidder for a maximum period of fifteen (15) days after the expiry of free period of five (5) days as mentioned at Sl. No. 4 on payment of Ground Rent by the purchasers as per tariff applicable.
6. If the purchaser fails to take delivery of the goods within the maximum period permitted by CWC on payment of rental warehousing charges as detailed above, the earnest money deposited by them will be automatically forfeited and the cargo will be re-listed for the sale without any further notice.

14. Resale will not be recognized & delivery orders will be made in the same name of actual bidders only.
15. In case of CWC unserviceable items / scrap goods sold by weight, the purchaser will be required to make his own arrangement to provide weighing scale, labour for the weighment of the lots at the site of delivery at his costs and shall remove the goods after the actual weight is ascertained.

26. i) For all the goods sold on subject to mutilation and fumigation and allied Custom/Assistant Drug Controller/ Food Safety and Standards Authority of India(FSSAI)/ Pollution Control Board formalities, free period of 30 Calendar days only will be allowed for completing all formalities from the date of confirmation of offer. If the concerned authority does not certify the approval within the time specified, the purchaser will have the option to come forward and withdraw the offer within 15 days i.e. before the expiry of 45 calendar days from the following date of confirmation of the offer. If the purchaser does not apply for cancellation of sale, the warehouse rental charges as notified in the CWC Tariff will be recovered from the 31<sup>st</sup> day following the date of confirmation of offer. The earnest money deposit/ Purchaser's Price will be forfeited and the sale will be cancelled if the purchaser does not withdraw the offer between 31<sup>st</sup> day and the 45th days following the date of confirmation of the sale. Goods shall be mutilated only under Custom Supervision to avoid misuse of Trade Mark, Name, etc.

27. i)To ensure that consignments of bulk drugs and other items which are sold only to actual users i.e. manufacturers holding valid manufacturing license under Form 25 and 28 with valid permission for the usages of the said bulk drugs/other items as specified in its formulation, the bidder should attach the following documents to their offer forms:
- ii)Counterfoil of the application form along with a photo-copy, submitted by the actual user holding license to the bank for obtaining Demand Draft/ Pay Order should be attached to the offer form along with the DD/PO.
- Likewise, the purchaser while bidding in auction should produce the documents (i) in original or copy duly certified by the Asst. Drug Controller, Mumbai. Initial verification of requisite documents will be done by the officer of Sales branch attending tender. Only the authorized representative of the manufacturing firm is permitted to bid in the auction. He should produce authority letter from his firm for inspection before acceptance of the offer. The EMD amount may be paid in DD/PO along with the counter foil of the form submitted by the actual manufacturer holding license for obtaining DD/PO. The balance sale price should also be paid by the purchaser by DD/PO as specified under Special Condition No. 5 only.
28. In case of Drugs etc. such as Citric Acid, Potassium Permanganate, Phenyl etc which may be found fit for medical or non-medical use as advised by the Asst. Drug Controller from time to time, offers will be entertained from the actual users only and while giving the offers at the time of Tender/ Auction, they should fulfill condition No.8 otherwise their EMD stand forfeited. However, in case where Asst. Drug Controller has already certified the drug for non-medical use only, the actual user condition is not applicable. The delivery of such lots, which are certified for non-medical use, will be given after making as "NON-MEDICAL USE" on the packing in presence of Asst. Drug Controller. In such cases, it is the responsibility of the bidder to bring ADC.
29. In case of non approval of the lots by the ADC/FSSAI, the sale of lots will be cancelled and EMD refunded to the successful purchaser. The approval of the Authority concerned shall have to be obtained within a maximum period of 30 days failing which EMD will be forfeited.

30. All the goods sold at the Auction sale shall lie at the sole risk of the purchaser until the goods are removed.

## INSTRUCTIONS TO THE e-AUCTION PARTICIPANTS

### 1.0 Steps for Actual Bidding Procedure

- 1. Go to [www.ashvinauctioneers.com](http://www.ashvinauctioneers.com) ; New Bidders register yourselves by clicking on New User Button. Then Ashvin & Co. Admin will activate your account. Please submit Pan Card Copy, VAT Copy, Auction Registration Form (Annexure A or B or Both) mentioned below in this catalog.
- 2. First Enter in the bidder room use your own – “user name” and “Password”.
- 3. Auction Room: After paying CMD a key will be sent to you in your registered e-mail id. A key is to be inserted in AUCTION ROOM BUTTON & you will be entered in Auction room.
- 4. Click on to place bid
- 5. Ie. This will take you to the Bidding Page. A separate Window opens which is the Bid room.
- **6. Manual / Auto Bid Now Start Bidding.** You can either Bid Manually OR can use Auto-Bid. (In Auto bid, the computer will bid on your behalf up to that value you have given.)
- In the Manual Bid option, you can put your bid in the text box available for each ITEM and submit it every time. A bid confirmation pop up box will appear to confirming whether you want to go ahead with the bid posted or not. **If you confirm the bid, your bid will be posted.** If your bid is accepted, that will be displayed in “Your bid” column on your right side screen. Also the highest bid amount will be displayed in “Highest bid” column. If you are the highest bidder at the time, **“Your Bid” column will be highlighted with “green” background.**
- During the auction, the current highest bid of the bidder, the bid status and the bid history can be viewed on the screen all the times. Bids can be placed at the specified time mentioned during the auction day.
- Enter your starting bid amount in “Your Amount” text box, the minimum increment is a optional text box by default it will take the minimum increment amount which is fixed by the company for that product. Enter the maximum amount in the “Maximum Ceiling Amount” text box. Submit your auto bid after filling all the above values.
