- 2. The highest Auction Bid will be accepted subject to confirmation by the Management of **Haldia International Container Terminal Pvt Ltd**.
- 3. All the lots are sold subject to reserve price fixed by the competent authority. The sale of LOTS is Subject to the reserve price, if any, fixed by the SELLER and subject to the term and conditions set out herein, sale shall be made to the HIGHEST BIDDER on "AS IS WHERE BASIS" and "NO COMPLAINT BASIS IS."
- 4. Any lot can be withdrawn from the auction sale by the "Management of Haldia International Container Terminal Pvt Ltd," Administration without assigning any reason.
- 5. Lots may be sold bigger, smaller or joint lots than those mentioned in the auction Catalogue.
