- 1) The intending Bidders shall have to register on the website of www.ashvinauctioneers.com by Clicking on to the NEW USER.
- 2) Fill up the registration form.
- 3) Take out the print out of the registration form on Company's/private letter head.
- 4) **Submit the hard copy of the registration form with the below mentioned documents**
 - a) **Pan Card of Proprietor OR Pan card of Company**
 - a-i) **Pan Card of Partners**
 - a-ii) **Pan Card of Authorized person with Authority letter**
 - b) **Photographs of signing authority.**

 - f) **PCB/MOEF License (If Applicable)**

All the above documents have to be self attested.
- 5) **The registration form shall have to be submitted along with non refundable registration fee of Rs. 11,111 + 18% GST (2000) = 13,111/- Demand Draft in the name Ashvin & Co. Demand Drafts shall be submitted in the office of Auctioneers Ashvin & Co. Mumbai Office.**
- 6) **Separate LOT WISE CMD (pre-bid EMD) or Rs. 5,00,000/- for All the LOTS as specified in the list for E-Auction in the form of Demand Draft in favor of **Tata BlueScope Steel Pvt. Ltd**, payable at **Par** shall have to be submitted in the office of Ashvin & Co office at Mumbai.**

- 2) "Winning bidder has to arrange 10% Security Deposit after the finalization basic value within 48 hours of confirmation of results in the form of Pay Order / Demand Draft to be drawn on ""Tata BlueScope Steel Private Limited"" payable at Pune.
- 3) Security deposit is 10% of Total Basic value & no partial payment of security deposit will be allowed. In case of partial payment of security deposit seller keeps the right to cancel /reject the delivery order .Security Deposits shall be refunded after the contract period is over, free of any interest.
- 4) Winning buyers are required to lift the machines against full payment sin (inclusive of taxes and duties applicable) in advance by DD regularly till the contract is over on a regular basis. You will visit for lifting the sMaterials/ Machines as per Minutes of Meeting or as per mutually agreed dates, without fail. The Seller shall be entitled to hold back the material if full payment is not received." Successful bidder has to deposit full payment with taxes. After Receipt of total Sale Amount from the successful bidder delivery of the lot will be allowed.
- 5) In case reserve price is not met, the bid will be treated "Subject to Approval" and highest bidder will be intimated / informed about the seller's decision within 30 days after date of auction. If the bidder to whom the material has been offered fails to pay within 7 days after sellers decision his Bidders security deposit will be forfeited and the bidder will not be allowed to participate in future auctions.
- 6) In case the winning buyer does not make payment of security deposit within 48 hours then the Bidder Deposit of the winning buyer would stand confiscated. In such a case the seller may offer the contract to the 2nd highest bidder.
- 7) During the contract period if there is any delay in making of any of the payments or lifting of material within the prescribed time frame will render the Buyer liable to forfeit the payments made and offer the contract to any other buyer.
- 8) Tata BlueScope steel Pvt. Ltd. reserves the right to terminate the contract and / stop the supplies of the Scrap at any time during the Contract Period, if Tata BlueScope steel Pvt. Ltd. wishes to use the scrap for their own purpose i.e.selling of scrap to Tata BlueScope suppliers or subcontractors.

- 9) Refund of leftover money must be claimed well in advance after completion of lifting tenure, it will take at least 20 days to refund money after check and getting clearance from our audit committee.
- 10) DD's from nationalized bank only will be accepted at Tata BlueScope Steel Pvt. Ltd.
- 11) Bidder's representative must follow instructions of Tata BlueScope steel authority when loading machines/ materials in the vehicle, in case of any dispute Tata BlueScope will forfeit entire amount available with TBSPL and black list the bidder to take part in future auctions held for Tata BlueScope steel Pvt. Ltd.
- 12) NO pick and choose will be tolerated at the time of loading the vehicles, it's responsibility bidder to see lots physically before Auction and no deviation in this will be allowed.

The bidder is deemed to have inspected, examined reasonably and satisfied himself as to all matters regarding condition, quality and type of the material. No question or claim whatsoever in this respect shall be entertained after submission of the bid. The seller will not be in any manner responsible for any damage/deterioration of the material, if the salable material is kept in the "Loading / Unloading" in open space. The Seller shall not be in any manner liable whatsoever for the performance of the material.

All Sales are strictly on "**As is, Where is basis**", and **No Exceptions**, thereof. Buyers are advised to obtain all relevant information during inspection of the assets before Bidding. Seller Company or auctioner agency will not entertain any grievances **post Auction** and also Tax Liability, Warranty or Guarantee of the quality, quantity, measurement, condition, defects in any item/s or lot/s from the Bidder's end.

Please Inspect the assets as there may be missing parts / equipment in the Set. Please satisfy yourselves with the condition of the equipment being sold. The material /machines will be sold on prorata basis without any regard or consideration to this and no warrantee shall be implied.

C. Tata BlueScope steel pvt Ltd.. Ltd. shall be under no obligaton to put up the lots singly or serially or in any particular manner and they reserve the right to withdraw any lots at any time during the period of auction without assigning any reason thereof. Tata BlueScope Ltd.. Ltd. may refuse to accept any bid from any person /persons without assigning any reason for such refusal.

D. In case the buyer fails to lift promptly the Arising materials/ Machines , then the contract & material will be sold to any other party and difference will be recovered from the contractor and / or Security Deposit will be forfeited forwith and contract will stand terminated.

Bidders has to submit Completely Filled and Signed Bidder Undertaking Form and signed.

PAN & GST No. is mandatory for participating in the Auction. Buyer has to submit Copy of PAN Card and GST Certificate.

SELLER may disqualify any bidder from taking participation in the Auction , if found or discovered any CARTEL amongst the Bidders.
No proxy bid allowed .

2. TAXES AND DUTIES.

A. Taxes and Duties applicable will be charged extra on the bidded rates, as mentioned above and as per budgetary change.

B. The winning bidder will be liable to provide forms as applicable for concessional Sales Tax while lifting the material. Failing which the seller shall charge Full Sales Tax as per prevailing rates.

C. All Taxes duties like Goods Service Tax whether payable to the Central Government authorities shall be deposited by the buyer with the Seller along with the purchase money as part of the final payment.

D. The buyer should furnish copies of his Goods service Tax Registration Certificate, incase required by the seller.

3. DELIVERY OF MATERIAL:

A. The buyer will make his own arrangement for lifting and transportation of material from the seller's premises. However, the seller will only guide in loading and weighing (if on weight basis) of material. Buyer will not be entitled to claim any further facility or assistance in this regard. The material sold on weight basis will be weighed on seller's or authorized weighbridge in the presence of seller's representative. The weights recorded on the Tata BlueScope steel Pvt. Ltd weighbridge will be final and binding on both parties. No complaints as regards the shortage in the weight will be entertained later.

B. The buyer is not entitled to choose or pick any particular material/machine from the lot. He has to lift the entire material/machine as available in the lot and as per the directions of the seller's representative.

C. The buyer is not allowed to lift any material other than the material described in the Lot even if such material is found in the storage yard at the time of taking delivery. The material other than described in the lot but found at the site belongs to the seller and should not be lifted. In case, any successful buyer is found collecting material belonging to the seller willfully, severe action may be instituted against such buyer by the seller. This may include even lodging of Police Complaint.

D. The material delivery will be effected during working hours only between 8:30am to 4:00pm (except holidays and Weekly off) and with appointment confirmation from the Seller.

F. For any natural imbalances , no special consideration will be given to the bidders but he has to lift the material as is where is basis.

G. Winning buyer should give PO to Tata BlueScope steel pvt. Ltd. before Lifting of material Buyer should be agree to below condition before Auction

Winning Buyer's Scope:

- A. All tools & tackles required for Dismantling of machinery will be in your scope
- B. All necessary consumables will be in your scope including packing of machinery
- C. Loading of complete mechanical equipment and electrical panel will be in your scope.
- D. Staff and worker's accommodation, conveyance, food will be in your scope 5. PF, WC Policy and ESIC of the workers will be in your scope 6. Farhana (Mobile) crane wherever required will be arranged by you as per the required capacity intimated by TBSL Operations Team
- E. Transportation from our Hinjewadi, Pune works to the desired destination would be arranged by buyer itself. Seller/TBSPL will not hold any responsibility of once material get dispatched from their hinjewdai plant premises.
- F. Dismantling, lifting and transporting of material will be the buyer(s) responsibility **at their own Cost**. Any mis-happening at the time of dismantling, packing, lifting, loading of machines / Materials will not constitute any liability on the Seller's end. The winning buyer is responsible to keep the factory in order after removal of sold lots. In case of non-adherence, seller may deserve the right to impose penalties or forfeiture of payment deposited.
- G. Winning buyer shall employ or engage their own personnel at their own cost for lifting of sold material. Seller is not responsible for claim against any injuries, death etc during lifting.
- H. The authorized personnel of the winning buyer visiting the factory for lifting the disposable materials should necessarily carry due authorization letter and proper photo identity.
- I. Any loss or damage to Tata BlueScope steel Pvt. Ltd. property or their engaged contractors due to faulty work by winning bidder or their representative at Hinjewadi plant will be recovered immediately & from the amount deposited by winning buyer .

4. **FORFEITURE / PENALTY:**

A. **SECURITY PAYMENT:** In case of delay in making the payment penalty at the rate of 0.2% per day (prorata) of the material value will be charged. On further delay beyond 1 week (plus extension granted if any by the seller in special cases), the bidders deposit will stand forfeited. In such a case the bidder will be declared as backed out and the opportunity of purchase will be given to the next highest bidder.

B. **100% PAYMENT & LIFTING OF MATERIAL:** Absolutely necessary to put a vehicle as per schedule ,failing which Rs 2,000/- ground rent per day will be charged for a period of four days beyond which the lot will forfeited with deposit .The company is free to claim such further losses , damages caused by the bidder for failure to lift the material

Seller shall not be liable for non-performance of any contract either wholly or in part nor for any delay in performance resulting due to cases beyond seller's control including fire, strikes, lock-out, closure, dispute with workmen, uncertain and unstable labor situation, war, riots, civil commotion, pestilence, epidemic, floods, accidents, damage or requirements of Government force or any circumstances. Should seller so determine shall be entitled at any time without notice to the buyer to cancel any contract the performance of which is likely to be delayed by any of the cause aforesaid and in such cases, the buyer shall have no claim upon the seller of any kind, The provision of this paragraph shall not be limited or abrogated by any other terms of the contract whether printed or written nor will be provision of this clause abrogate or limit the effect of any other clause mentioned in these terms and conditions.

In case any buyer purchases a lot and after making full or part payment removes part of the Lot and fails to remove the balance lot then, after the stipulated time is over (including the extension granted if any), the lot will be treated as abandoned and whatsoever money is paid for the lot will be forfeited along with the Down Payment etc. and the balance lot will be disposed off by company as it deems fit.




