- 2) Fill up the registration form.
- 3) Take out the print out of the registration form on Company's/private letter head.

**4) Submit the hard copy of the registration form with the below mentioned documents :-**

All the above documents have to be self attested.

1. 2. The highest Auction Bid will be accepted subject to confirmation by the Management of **CMA CGM Shared Service Centre (India) Pvt. Ltd. (CMA CGM)**
3. All the lots are sold subject to reserve price fixed by the competent authority. The sale of LOTS is Subject to the reserve price, if any, fixed by the SELLER and subject to the term and conditions set out herein, sale shall be made to the HIGHEST BIDDER on “AS IS WHERE BASIS”, “NO COMPLAINT BASIS IS” and “AS IT LYING BASIS”
4. Any lot can be withdrawn from the auction sale by the “Management of **CMA CGM**,” Administration without assigning any reason.
5. Lots may be sold bigger, smaller or joint lots than those mentioned in the auction Catalogue.

6. “Goods fit for intended use are sold as they stand...” All goods are sold in the condition they stand i.e. “AS IS WHERE IS BASIS”. The quantities, qualities, sizes, measurements, number and weights, whether announced verbally at the time of sale or specified in the catalogues are approximate. All goods are sold on the assumption that the bidders have inspected the goods and know what they are buying whether they have actually inspected the goods or not. 7. The Weight or Number, quantity against the respective Lots are indicated approximately which in actual may turn out to be more or less than the indicated quantity. - 3. Auction Room: After paying CMD a key will be sent to you. A key is to be inserted in Login ID & you will be entered in Auction room.
- 4. Click on to place bid
- 5. Ie. This will take you to the Bidding Page. A separate Window opens which is the Bid room.
- **6. Manual / Auto Bid Now Start Bidding.** You can either Bid Manually OR can use Auto-Bid. (In Auto bid, the computer will bid on your behalf up to that value you given.)
