- 1. **SELLER:** Seller referred in these conditions of sale, **APM Terminals India Pvt. Ltd.** a company registered under the Indian Companies Act, 1956 having its CFS operations at the address mentioned hereinabove.
- AUCTIONEER: Ashvin & Co is an agency appointed as an auctioneer to facilitate auction on Internet by the Custodian.
