- g. RULES AND REGULATIONS: The contractor shall follow all the rules and regulations under contract Labor Act, Factories Act, Industrial Dispute Act, Payment of Bonus Act, PF Act, ESI Act, Gratuity Act, Maternity act, All India Motor Vehicle Act 1988, Rajasthan Motor Vehicle Rules 1951, as amended up to date and other laws in force during the currency of Contract.
- h. All trucks, handcarts, carrying such materials outside our premises are subject to inspection by our Security Deptt. at the gate. If required, the buyer will have to unload the vehicle if Security Officer Demands for a surprise check.
- i. Any person employed or engaged by the buyer for the purpose of the execution of the contract shall be required to observe the rules and regulations that are prevailing in our Company. The movement of his persons shall be restricted only to the place of work assigned to them. Each person engaged by the buyer shall be required to obtain a Pass from our Security Department for entering and leaving our Factory premises. All the labour engaged by the buyer shall be subjected to inspection by our Security Dept.
- j. All notices, letters sent to the purchaser shall be deemed to have been received by him/them on expiry of 48 hours from the time of posting if the same are sent at the address given by the purchaser.
- k. If any person/s bid at the auction on behalf of the undisclosed principal, he / they shall immediately after the bid at the time of payment of EMD, disclose the name of his / their principal who is the actual purchaser and the receipt for the caution money and/or earnest money would be issued in the name of the principal.
